I also agree to exempt and release forever the FIG, PA it’s agents, officers, and employees, whether acting officially or not, for any liability, claims demands, or actions, or causes of action whatsoever arising out of my damage, loss, or injury to me or my personnel property raising out of my participation in this event, whether such loss, damage or injury results from the negligence of FIG, PA officers, agents, employees.
